## Letters Patent constituting the office of Governor-General, 29 October 1900

**Now know ye** that there shall be a Governor-General and Commander-in-Chief shall be from time to time appointed by Commission under Our Sign Manual and Signet. These **Letters Patent** are copyrighted to the Queen. Signet, removed by the Political Parties on the 18th December 1959, = Treason

**Proclamation** 2nd February 1960 show this.

By removing the signet, Political Parties have taken ownership of the Governor-General and Commander-in-Chief. Therefore changed Commonwealth of Australia Constitution Act 1901, Clause 2 and Section 61 without a Referendum = Treason. No Royal Assent to any Act from this date forward.

**III. The** Governor General may constitute and appoint, in Our name and on Our behalf, all such Judges, Commissioners, Justices of the Peace, and other necessary officers and Ministers of Our said Commonwealth, as may be lawfully constituted or appointed by Us.

All Judges, Commissioners, Justices of the Peace, and other necessary officers and Ministers are owned and controlled by Political Parties, No Separation of Powers, No Guardians of the Constitutions, No Common Law of England = No Rights.

Political Parties sent our Commonwealth Defence Forces to Vietnam.

Commonwealth Defence Forces were for the Defence of the Commonwealth.

In 1965 Commonwealth Political Parties and all State Governors and Parliaments agreed to the Political Parties Dollar outside the Commonwealth of Australia Constitution Act 1901 = No Head of Power = Treason.

14th February 1966 the Fraudulent Political Party Dollar became into being. This dollar is Counterfeit to the Commonwealth of Australia Constitution Act 1901. The rest of the States joined with their Australia Acts (Request) Act 1985 = Treason.

**Law and Justice Legislation Amendment Act 1988 (Cth) Act No. 120** of 1988 which amended

Judiciary Act 1903 No 6  
Common Law to Govern

Section 80, replacing "common law of England" with "common law in Australia".

The contrary intention has never appeared of the Political Parties changed

## Description of the Shield

Symbols of Australia's six states appear on the shield:

- New South Wales – the Cross of St George with lion and stars
- Victoria – the Southern Cross
- Queensland – a blue Maltese Cross and Crown
- South Australia – blue flag with five stars Southern Cross
- Western Australia – a black swan
- Tasmania – a red walking lion



### First Quarter (representing New South Wales)

Background silver, featuring the Cross of St George containing an heraldic gold lion, walking to the wearer's right (viewer's left), three paws on the ground, the right forepaw being raised, the head turned so as to face the spectator and the tail curved over the back, and on each arm of the cross an eight-pointed gold star.



### Second Quarter (representing Victoria)

Background blue, containing five stars, one of eight points, two of seven points, one of six points and one of five points (the constellation of the Southern Cross) with an Imperial Crown in normal colours placed above the first star.



### Third Quarter (representing Queensland)

Background silver, containing a blue Maltese Cross surmounted by an Imperial Crown in normal colours.



### Fourth Quarter (representing South Australia)

Blue flag with five stars four with seven points and one with five points, (constellation of the Southern Cross), Lion in gold, Female holding Cornucopia and a sheaf of barley, farmer holding a pair of shears and over his arm a fleece of wool.



### Fifth Quarter (representing Western Australia)

Background gold featuring a black swan swimming to the wearer's left (viewer's right).



### Sixth Quarter (representing Tasmania)

Background silver, featuring a red lion walking to the wearer's right (viewer's left) three paws on the ground, the right forepaw being raised, the head looking forward and the tail curved over the back.
